# **Privacy Policy**

## **What This Privacy Policy Covers**

This policy covers how Next Level Performance treats personal information that Next Level Performance collects and receives, including, without limitation, information related to your past use of Company products and services. Personal information is information about you that is personally identifiable, such as your name, address, photograph, email address or phone number, and that is not otherwise publicly available.

## **Information Collection and Use**

Next Level Performance collects personal information when you visit this website in different ways including, without limitation, when you visit this website or the website of certain partners. Next Level Performance automatically receives and records information on our server logs from your browser, including your IP address, website cookie information and the particular page(s) you visit on this website. At this time the website does not specifically respond to do-not-track signals. ## **Information Sharing and Disclosure**

You may only make a verifiable consumer request for access or data portability twice within a 12-month period. The verifiable consumer request must:

1. Provide sufficient information that allows Next Level Performance to reasonably verify you are the person about whom we collected personal information or an authorized representative.
2. Describe your request with sufficient detail that allows Next Level Performance to properly understand, evaluate, and respond to it.

Next Level Performance cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you. Next Level Performance will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

### **Response Timing and Format**

Next Level Performance endeavors to respond to a verifiable consumer request within forty-five (45) days of its receipt. If Next Level Performance requires more time (up to 90 days), we will inform you of the reason and extension period in writing.

If you have an account with Next Level Performance, we will deliver our written response to that account. If you do not have an account with Next Level Performance, we will deliver our written response by mail or electronically, at your option.

Any disclosures Next Level Performance provides will only cover the 12-month period preceding the verifiable consumer request's receipt. The response Next Level Performance provides will also explain the reasons we cannot comply with a request, if applicable.

Next Level Performance does not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If Next Level Performance determines that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

### **Personal Information Sales Opt-Out and Opt-In Rights**

Next Level Performance does not sell the personal information of consumers. Consumers who opt-in to provide personal information may opt-out of at any time. The data collected from these cookies helps us to analyze browsing patterns of our visitors and improve the content and design of the website. ### **Privacy Rights for California Residents (or “California Privacy Rights”)**

This Supplemental Privacy Policy applies solely to all residents in the state of California. This Supplement is adopted to comply with the California Privacy Rights Act of 2020 (CPRA).

Next Level Performance only collects, uses, retains, and shares personal information as reasonably necessary in furtherance of Next Level Performance’s purposes. In the preceding twelve (12) months, Next Level Performance has not sold any personal information. Next Level Performance may disclose personal information to a third party for business purposes. When Next Level Performance discloses personal information for business purposes, we enter a contract that describes the business purpose(s) and requires the recipient to both keep that personal information confidential and not use that personal information for any purpose except performing under the contract. The CPRA prohibits third parties from re-selling your personal information unless you have received explicit notice and have not opted-out of such a sale. Next Level Performance may share personal information with third party service providers. Next Level Performance discloses personal information for business purposes to the following third parties: Microsoft Azure, NGC, Save On Resort, Vivid Seats, and Replink.

Once Next Level Performance receives and confirms your verifiable consumer request, we will disclose to you:

2. The categories of sources for the personal information Next Level Performance collected about you.
3. Next Level Performance's business or commercial purpose(s) for collecting or selling that personal information.
4. The categories of third parties with whom Next Level Performance shares(ed) that personal information.
5. The specific pieces of personal information Next Level Performance collected about you (also called a data portability request).
6. If Next Level Performance disclosed your personal information for a business purpose, identifying the personal information categories that each category of recipient obtained.

Next Level Performance will not discriminate against you for exercising any of your CPRA rights. Unless otherwise permitted by the CPRA, we will not do any of the following in response to your exercise of any of your rights under the CPRA:

1. Deny you goods or services.
2. Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
3. Provide you a different level or quality of goods or services.
4. Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.

However, we may offer certain financial incentives permitted by the CPRA that can result in different prices or rates. Any CPRA-permitted financial incentive offered will reasonably relate to the information's value and will contain written terms that describe the incentive's aspects.
